

HIMSS EHR Association Definitional Model and Application Process March 2009

Background:

The HIMSS Electronic Health Record (EHR) Association chartered this effort to ensure equal, fair and consistent criteria for Membership into the EHR Association. The EHR Definitional Model includes an operational EHR definition, key attributes, essential requirements to meet attributes, and measures used to assess the extent to which companies design, develop and market their own proprietary Electronic Health Record software application.

Electronic Health Record Definition:

The Electronic Health Record (EHR) is a longitudinal electronic record of patient health information produced by encounters in one or more care settings. Included in this information are patient demographics, progress notes, problems, medications, vital signs, past medical history, immunizations, laboratory data and radiology reports. The EHR system automates and streamlines the clinician's workflow. The EHR system has the ability to independently generate a complete record of a clinical patient encounter and possesses sufficient data granularity to support clinical decision support, quality management, clinical reporting, and interoperability.

Membership Guidelines:

Organizations wishing to become a member of the EHR Association will be required to meet the following requirements:

- The applicant company must be a HIMSS Corporate Member in good standing with HIMSS. If your company is not a corporate member, you may apply by completing the registration at the following site: www.himss.org/asp/corporateMembership_join.asp.
- The applicant company must design, develop and market its own proprietary Electronic Health Record (EHR) software application.
- The applicant company must be an Electronic Health Record (EHR) vendor that is a legally formed company in good standing.
- The applicant company must be an Electronic Health Record (EHR) vendor that makes their EHR software application commercially available in the United States of America.

• The applicant company must be an Electronic Health Record (EHR) vendor that has, at a minimum, five (5) EHR customer installations in commercial use in the United States.

1. Additional Assessment Fee of Membership:

During the July 14, 2009 full EHR Association membership meeting, it was discussed, voted upon and approved to move forward on a member assessment for an additional fee of the members of the EHR Association to facilitate a greater presence in the marketplace for our organization.

The assessments are based on the following: (The assessment is based on total revenues, not EHR revenues.)

- Member companies with less than 5M in annual revenues \$495/yr.
- Member companies between 5M and 25M in annual revenues \$1,980/yr.
- Member companies with over 25M in annual revenues \$ 4,050/yr.

Note:

- This assessment would be in addition to the HIMSS normal corporate membership.
- This assessment appears at this time to be an on-going assessment, but can be reevaluated at the end of the fiscal year.
- The vote on July 14, 2009 was for an annual assessment but the membership can vote to change that at any time.
- The timetable for the annual assessment will coincide with the HIMSS Annual budget, July 1, 2009 through June 30, 2010.

In the near term, the Work Group will handle the rollout plan of the Interoperability Roadmap.
	COMMUNICATIONS WORK GROUP
	The Communications Work Group mandate is to position the association, its members and its initiatives, as leading the HIT industry trade organization during these fast-paced and critical times in the adoption of electronic health records. They will be responsible for defining and executing the marketing and communications plan, which includes formalizing channels and developing the necessary tools for the EHR Association to communicate with all stakeholders including current and potential EHR Association members, the healthcare provider community, third party organizations, and handling public relations and media outreach.
	GOVERNMENT INITIATIVES & ORGANIZATIONS WORK GROUP
	The Government Initiatives & Organizations Work Group sets strategy for interaction and participation with established government and private sector initiatives related to EHR. This group will continue to drive the responses to and relationship with CCHIT.
	MEMBERSHIP COMMITTEE
	The Membership Committee (MC) manages all membership criteria and materials as well as recruiting new Member activity for the EHR Association. In addition, the Membership Committee manages the election and selection processes for EHR Association Board and Committee Chairs and Vice Chairs. The MC also helps set the agenda for the EHR Association face to face member meetings.
	STANDARDS & INTEROPERABILITY WORK GROUP
	The Standards & Interoperability Work Group evaluates all standards and third party standards setting organizations and establishes a strategy for interacting with each. Initial interoperability projects are focused on HL7, CCR, RHIO, IHE, Lab terminology and Security standards.
